### **Agenda 2 Treasurer Report**

### Agenda 3 - Pierhead Report

There was considerable discussion on this agenda item. There was overwhelming support for pursuing the community demand to have enhanced facilities for recreation and leisure on the site, instead of Argyll & Bute's stated intention to pursue a retail option for the site. An initial meeting between the Community Council and Argyll & Bute was a welcome opportunity to state our respective views. A second meeting has been agreed to continue the discussions. A positional statement has been produced by the Community Council which will be tabled at this meeting to re-emphasise our position and gain acceptance of our proposals

**Action** - The Community Council will confirm the date of the second meeting and table our position statement to further reinforce the community case.

## Agenda 4 – Bin Discussion and Future Action

The bin survey conducted by Plastic Free and ourselves forms the basis of future improvement in the functionality and location of suitable litter bins. Progress is patchy at the moment but we are expecting improvement shortly. A further issue concerns the placement of contract bins which may cause obstruction on pavements and an unsightly feature in the town centre

**Action -** Plastic Free will investigate the situation regarding industrial bins and the Community Council will press ahead with the renewal programme for town litter bins.

## Agenda 5 - Town Entry Signs

TD gave an update on the situation. We are still hopeful that the signs will be manufactured.

Action - We will continue to monitor the situation.

# Agenda 6 - Hybrid meetings and Webinars

It was generally agreed that the webinar programme had been a great success in
