Waterfront Campaign

Polly Jones provided an update on the rally and petition. Digital petition stands at 4500 + paper: total nearing 5000. 400+ residents at rally with support from skateboard park. Need to decide how to present petition to A&B council. Please keep writing to councillors.

Proposal to submit petition (legal document) for judicial review of waterfront decision (circulated beforehand). Within 3 months of decision, therefore deadline 15th Nov, Estimated cost £5000 for petition stage – covered by crowdfunding. HCC now a member of SCVO, so can instruct an advocate directly. We are applying for pro bono advocate assistance and protection from liability. HCC unanimously approved the motion to proceed with the judicial review.

Complaint lodged with Public Service Ombudsman re Area Committee questions.

Agreed need for a legal vehicle for potential community transfer. Will be a SCIO with a board and at least 20 members. Underway.

Presentation from Friends of Duchess Woods

Luss Estates is selling Duchess Woods-15 acres of urban woodland. Presentation explained the history of the woods and the Friends organisation. Friends do not believe they have the expertise or resources to maintain the woods, which do not offer a significant source of revenue. Sale is to be finalised 13th November. HCC will continue to monitor.

Music in the Square: Enable have received their £300 grant, and invite HCC to their session 7th Nov. Further applications are under consideration.
