Helensburgh Swimming Club Update

Swimming club has had no response from A&B Council or Live Argyll. The club has found alternative swim time in West Dumbartonshire but there is still a waiting list. The club has reported diminished members due to restrictions of swimming facilities due to the closure of the Helensburgh leisure centre. Club is proposing a temporary inflatable swimming pool for members, Cllr. Howard stated this has been declined due to risk assessment stating it would be too dangerous to the public. Club can no longer put forward swimmers for competitions. Impact statements were from delivered by a young swimmer and a parent regarding the ongoing closure of the pool.

Can Cllr Howard forward a copy of the risk assessment stating that a temporary inflatable pool would be dangerous. Cllr Howard responded that she would try.
